The incumbent must possess good communication skills, be self-motivated, and well organized while continuously aligning daily functions to reflect Barkerville Gold Mines Ltd. values.

### Main Responsibilities

- Be a courageous safety leader and promote BGM's safety culture;
- A good team player who fits well within a healthy team environment and works in a cooperative manner with cross shift;
- Ensure adherence to laboratory policies & procedures;
- Reporting accurate sample analysis results in a timely manner;
- Operate Analytical Instruments;
- Perform work in Sample Preparation, Fire Assay, and Wet Laboratory;
- Prepare daily, weekly, and monthly reports and submit to the supervisor;
- Responsible for using chemicals and analytical methods to perform assaying duties;
